Welcome to the 3rd Edition of NovitasFTCL's European FinTech Private & Growth Equity Landscape

Despite Covid-19, European FinTech continues to be a vibrant sector for private equity and growth equity investment. Since the publication of our second edition in October 2019, the sector has attracted no less than 76 new investments, made by a wide cross-section of 51 funds in companies offering a wide range of financial technology solutions and technology-intensive financial services. The current environment did however affect the number of exits over the last 12 months, down to only 11 over the period.

Financial institutions continue to operate in increasingly challenging conditions, in many ways made even more difficult by the macro-economic context created by Covid-19. This background, combined with the ever increasing trend towards digitisation of financial services, continues to create growing demand for FinTech solutions and services.

But the current environment has affected different FinTech verticals in very contrasted ways, with B2C and B2B sectors faring differently. We can observe this in an increasingly polarised fund-raising landscape, with leading FinTech businesses in different verticals attracting an over-sized share of the available funding from private equity or growth equity providers, and other less fortunate players experiencing more difficult funding conditions.

Overall, we expect European FinTech to maintain its attractiveness to leading investors as we go into 2021. On the M&A front, that has been somewhat biased towards larger transactions during 2020, activity could become much higher within medium-sized deals, including many exits.

Data collection methodology

- This third edition once again focuses on growth and buy-out investments and excludes venture funding. The border between large venture and growth rounds is sometimes a bit subjective, and we have made judgements on a number of transactions.
- In line with overall market trends, we also observe some different types of investors entering our sample, such as Sovereign Wealth Funds and a few hedge and pension funds making direct investments.
- The strong increase in the number of transactions covered by this third edition reflects the increasing maturity of the European FinTech sector, and numerous growth equity investments in it.
- A broad definition of FinTech is applied which encompasses many technology verticals within the sector, as well as digital financial services and outsourced/managed services such as those found in the RegTech, InsurTech and funds-related sectors.
- The research is focused on the FinTech ecosystems of Western Europe and excludes Israel, Eastern Europe and the MENA region.

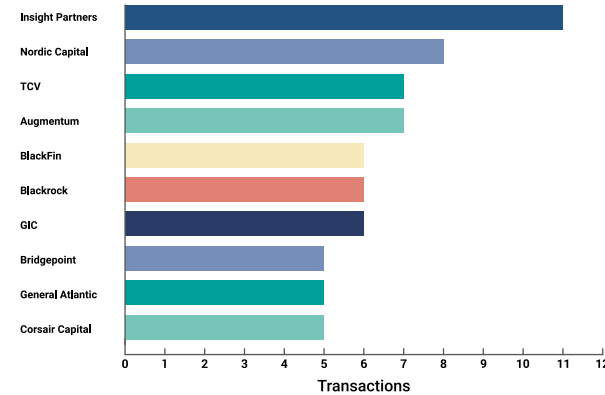
Transactions Per Region



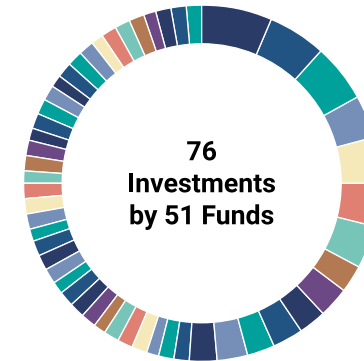
Transactions Per Year



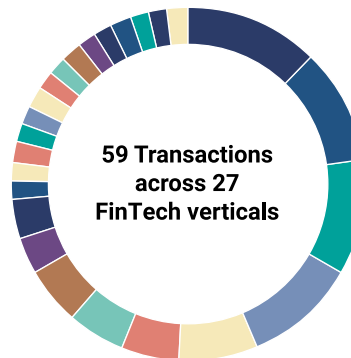
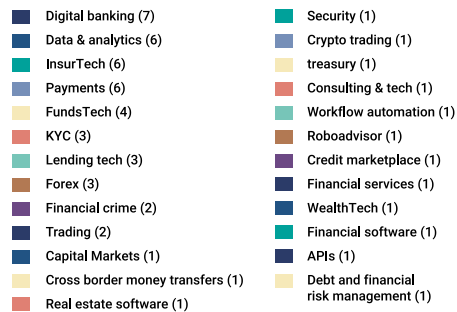

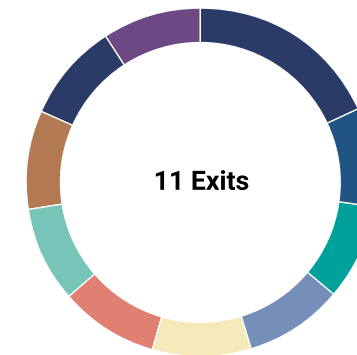
