

- July 2021 saw strong dealflow across 95 transactions with the Payments (26 deals) and BankingTech (23 deals) sectors together representing over 50% of monthly deal volumes
- Two landmark UK FinTech transactions with LSE's largest ever tech listing in the direct listing of WISE (formally Transferwise) valued at £8bn as well as Revolut raising \$800m at a \$33bn valuation, making it the UK's most valuable private tech company of all time, with a 6x uplift on their \$5.5bn 2020 valuation
- Consolidation also continues at pace in the fund administration sector with IQ-EQ (formerly SGG Group) making its 11th acquisition since it was backed by Astorg in 2016, the Apex Group made its 21st investment after its acquisition by Genstar and subsequent investments by Carlyle, TA and Mubadala, and the publicly listed Sanne Group made its 13th acquisition since its 2015 IPO
- Also noteworthy was Visa's £700m strategic acquisition of currency exchange API platform Currencycloud, Lloyds' £390m acquisition of investment platform Embark, excluding the Rowanmoor business, and buynow pay-later platform Klarna's announcement of three acquisitions in UK, Germany and Sweden as it builds its social shopping proposition
