- During February NovitasFTCL tracked 75 FinTech transactions comprising of 19 strategic acquisitions, 16 PE / Growth investments and 40 VC funding rounds.
- In payments, International Game Technology sold two Italian proximity payment subsidiaries, LIS Holding and LISPAY, to PostePay for €700m. In addition, recurring payment platform GoCardless raised a \$312m Series G at a \$2.1bn valuation led by Permira and BlackRock Private Equity Partners to speed up its expansion in open banking.
- In the digital banking space, Atom Bank raised £75m to fund future growth ahead of a planned IPO in 2023 led by BBVA, Toscafund and Infinity Partners whilst Intesa Sanpaolo invested £40m into core banking software provider Thought Machine to run its new digital bank Isybank
- Three other notable transactions took place during February. HgCapital-backed FE Fundinfo, a leading provider of fund data and technology, acquired Fundsquare from the Luxembourg Stock Exchange, welcoming it as a new investor and partner. FNZ, now valued at over \$20bn, raised \$1.4bn from Motive Partners and CPP Investments, in one of the largest ever primary capital raises in the wealth management sector. Lastly, Italian BNPL platform Scalapay raised \$497m in a major Series B round led by Tencent and Willoughby Capital (Daniel Och's family office), earning it unicorn status.
