

- During March NovitasFTCL tracked 82 transactions, comprising of 31 strategic acquisitions, 16 PE / Growth investments and 35 VC rounds. The Payments sector attracted the largest number of deals with 19 transactions, followed by BankingTech with 14, and Capital Markets and InsurTech recorded 10 deals each
- It was a busy month for M&A in the digital reporting space, including in the funds and wealth sectors. J.P.Morgan acquired Global Shares, a leading cloud-based provider of share plan management software. Allfunds, one of the world's leading B2B WealthTech platforms acquired Web Financial Group (backed by Bridgepoint). Deutsche Boerse Group acquired leading fund data manager Kneip, based in Luxembourg
 - Waystone, a service provider to the asset management industry, announced its acquisition of the Centaur Group, a fund admin and fiduciary services provider. HgCapital-backed FE fundinfo acquired French fund data and solutions provider Funds360 from Euronext. Lastly, in a noteworthy transaction, the London Stock Exchange Group agreed to divest BETA+ to Motive Partners and Clearlake Capital for \$1.1bn. The BETA+ businesses, formerly part of Refinitiv, provide back-office solutions to the wealth management industry
- In BankingTech, Heartland, IDC Ventures, Kinnevik and Tencent led an investment into Denmark's digital banking app Lunar, which raised €280m and wasted no time putting the funds to use acquiring Norway's Instabank for €132m just eighteen days later. Atalaya, Hive Learning and J.P.Morgan invested in the UK embedded finance platform Oakbrook, and Apple acquired Open Banking affordability / creditworthiness platform Credit Kudos, giving rise to speculation the tech giant may be about to enter the BNPL market
- A number of notable transactions in payments including commerce-enabling technology platform Shift4's \$575m acquisition of European payments platform Finaro (formerly Credorax), people management platform Papaya Global's acquisition of cross border payments platform Azimo to enhance its payroll payments capabilities and Blackstone Tactical Opportunities' £140m investment into FX platform Currencies Direct, whilst Palamon Capital and Corsair Capital retain their controlling stake


