



Introduction

Key insights

- This paper strives to provide an overview of the M&A and fund raising (both venture and growth capital) that took place in the European crypto sector since its inception in c.2010.
 Overall, we've listed a total of 378 deals: 212 venture rounds, 44 larger growth rounds and 122 M&A transactions
- We have tentatively defined the crypto landscape along 3 sectors and 16 sub-sectors (please refer to this taxonomy on p.3). Firms within the Trading, Investment, Blockchain and Payments sub-sectors have been most active deal-wise. Most deals in the Finance and Enterprise sectors have been venture rounds, whereas most deals in Infrastructure have been M&A in nature
- Geographically, transaction volume has been led by the UK (141 deals over the period), Switzerland (52) and Estonia (27). Germany and France follow
- Notably, there have been 25 European deals over \$100m, 13 over \$200m and 8 over \$300m
- Maybe unsurprisingly, investment into European crypto has been led by US firms. The three
 most active investors over the period having been DCG (Digital Currency Group), Coinbase
 Ventures and Pantera

- European (+Israel) firms primarily engaged in crypto related activity
- Involved in a transaction between January 2010-June 2022
- Estimated/reported transaction in excess of \$5m value





Deal Activity by Function


Crypto firms providing finance related services have accounted for two-thirds of transaction activity





















Most Active Investors by Deal Count






