#### AUGUST 2022 EUROPEAN FINTECH DEAL SUMMARY

• During August NovitasFTCL tracked 50 transactions, comprising of 14 strategic acquisitions, 3 PE / Growth investments and 33 VC rounds. This marked the third consecutive month of decline in transaction activity, albeit in a seasonally slow period. InvestmentTech attracted 14 deals, BankingTech 13 and Payments 11



• Payment deals accounted for half of the acquisitions tracked in August. This included the online remittance service provider Remitly acquiring Rewire, an Israeli based online service platform for migrants, for €79m. Also, during the month, French gift card platform Vaziva completed an initial public offering

• Acquisitions in the InvestmentTech space included SeedBlink acquiring Symbid, one of the world's first investment crowdfunding platforms. Also in the crowdfunding space, real estate crowd funding platform Upvest was acquired by KB SmartSolutions. InvestmentTech funding rounds included, Estonian crypto platform Bittlevex, Israeli investment tool software developer Agora, and investment platform Wombat


• In the BankingTech space, a consortium, including Accel-KKR, made a successful cash tender offer for the listed Finish firm Basware. Germany based Finleap Connect received funding, raising money from UK based Shackleton Investment, and UK firm Perenna received funding from IAG Capital Partners
