


- During October NovitasFTCL tracked 60 transactions, comprising of 24 strategic acquisitions, 12 PE / Growth investments and 24 VC rounds. This is the third month that VC deal numbers have declined and M&A risen both in absolute and relative terms, partly due to the more difficult funding environment for early-stage companies. Payments led activity this month with 18 transactions and BankingTech followed with 12 transactions
- In payments, listed SPAC CF Acquisition Corp. VIII
  merged with the European (bills and payments
  integrator) division of Exela Technologies Inc., in a
  \$220m enterprise value transaction and BNP Paribas
  acquired currency risk management business Kantox
  for a reported €120m
- In BankingTech, Agencia Italia, a subsidiary of the Italian listed Gruppo MutuiOnline, acquired Trebi

- Generalconsult, a leading company in the development and supply of software solutions for the financing sector (including, in particular, leasing). In addition, Natwest funded two companies in the space Vodeno, a cloud based open banking platform, and Floryn, an SME invoice financing platform
- In the RegTech space, leading specialist regulatory consulting firm fscom, advised by NovitasFTCL, completed an investment from Bridgepoint. Also, within compliance services, Thistle Initiatives received an investment from Copper Street Capital, Cube from Bregal Milestone and Charco & Dique from Projective Group
