• During June NovitasFTCL tracked 62 transactions, comprising of 22 strategic acquisitions, 7 PE / Growth investments and 32 VC rounds and 1 IPO. BankingTech attracted the largest number of deals with 17, followed by Payments with 16, and InvestmentTech with 8. It was a quieter month for deals involving Digital Assets recording just 8 transactions.

• In BankingTech, SME lending platform Teylor closed one of the largest European alternative private debt fundraises at €275m led by Barclays and M&G, neobank Blank raised €47m from Credit Agricole, and Avaloq, a subsidiary of the NEC Corporation formed a strategic partnership with BlackRock via their Aladdin Wealth business which also involved a minority investment.


• In Payments, the corporate payments division of the Swedish SEB Group acquired business travel and corporate payments platform AirPlus from Lufthansa for €450m, and account-to-account payments saw two fundraises with Atoa raising a £5m seed round backed by Valar Ventures, and Volt Technologies raising \$60m in their Series B round led by IVP.

• In FundsTech, the Vitruvian Partners backed Carne Group acquired GAM's third-party fund management services business, and Amicorp FS listed on the London Stock Exchange in a rare IPO for a sector in the midst a multi-year wave of consolidation that shows little sign of slowing.

• In InsurTech, Admiral Group acquired French online home insurer Luko. SME digital insurer Insify extended its Series A by €10m (€25m overall) led by Munich Re Ventures. And Thinksurance, a German firm specialising in digital insurance consultations for industrial and commercial clients, raised €22m led by MTech Capital, Segenia Capital and Viewpoint Ventures.
