


- During October NovitasFTCL tracked 63 transactions, comprising 26 strategic acquisitions, 6 PE / Growth investments and 31 VC rounds. Payments attracted the most deals (17), followed by Capital Markets (10) and InvestmentTech (10). In October, 8 transactions involved Digital Assets.
- In Payments, Payten acquired Ifthenpay, the omnichannel payment services platform, account-to-account payments platform Brite Payment Group raised \$60m led by B2B software investor Dawn Capital, and BNPL provider Zilch reported an undisclosed investment from eBay Ventures at a \$2bn valuation.
- In Capital Markets technology, leading crypto exchange Kraken acquired Dutch broker Bitcoin Meester. Private capital markets automation firm Globacap raised a \$21m Series B led by CBOE and QBN Capital. Untangled Finance, focused on bringing institutional-grade private credit onto the blockchain, raised \$13.5m led by Fasanara Capital. Lastly,


Sparta, a commodities-focused live market intelligence and forecasting platform, closed a \$17.5m Series A led by FirstMark and Singular.

• In InvestmentTech M&A, the Motive Partners backed With Intelligence acquired UK based provider of investor relations and research management solutions FolioMetrics, and Equation AG acquired fundraising and liquidity management platform Betterfront. The month's sole PE acquisition came in the form of Pollen Street Capital's buyout of niiio, the SaaS platform digitizing asset and wealth management value chains, and in venture, API investment platform for financial institutions Upvest raised €30m in a funding round led by ABN AMRO Ventures.
