
• During November NovitasFTCL tracked 59 transactions: 18 strategic acquisitions, 12 PE / Growth investments and 29 VC rounds. BankingTech and Payments both attracted the 15, followed by InvestmentTech with 10. Seven transactions involved Digital Assets.

• In BankingTech, Finch Capital backed open banking investment platform Crastorehill announced two acquisitions in Germany: Qwist, a provider of open banking payments and data, and API connectivity platform Ndgit. Vencora, a subsidiary of software aggregator Constellation acquired the listed Swiss digital banking and wealth management platform Crealogix, and UK challenger bank Atom raised £100m at a valuation of £362m in a deal led by BBVA, Toscafund and Infinity Investment Partners. • In Payments, Advent International acquired myPOS in a deal reportedly valuing the UK business at over \$500m, distributed-ledger platform for wholesale payments Fnality raised £77m in a Series B round led by Goldman Sachs and BNP Paribas. Tencent invested \$100m into tax free shopping and payments platform Global Blue, and international payments provider PaySend raised \$65m in a round led by Mastercard.

• In RegTech, Imprimerie Nationale acquired the e-Identity division of NEXI in a deal valued at up to €128m (€90m paid upfront, the remainder on an earnout basis). Compliance and investor relations provider EQS Group was taken private by Thoma Bravo, biometric anti-fraud platform BioCatch raised \$70m from Sapphire Ventures, and AML software provider Refine Intelligence raised \$13m in a Seed round led by Glilot Capital Partners and Fin Capital.


