



- During February NovitasFTCL tracked 74 transactions, including 28 strategic acquisitions, 13 PE / Growth investments and 33 VC rounds. BankingTech recorded the largest number of deals with 18, followed by Payments with 15 and Capital Markets with 9.15 transactions involved Digital Assets.
- In BankingTech, United Fintech acquired CBA (Commercial Banking Applications), a Nordic vendor focused on API-driven trade finance and payments solutions. Danish IT services firm Netcompany acquired banking solutions provider SDC for about €134m. SBI Group led a €140m Series G for German embedded finance firm Solaris, becoming its majority shareholder. Revving, an innovative invoice factoring platform for the AdTech sector, secured £107m financing from DWS (of which £100m in debt and £7m in equity). Wealthon, a Polish provider of digital financial solutions for SMEs, secured €125m in funding (of which €7m in equity from 3TS Capital Partners and a €116m debt facility from Fortress).
- In Payments, payments processor Shift4 agreed to acquire travel and retail payments platform Global Blue for \$2.5bn


- including Global Blue's tax-free shopping and payments technology across Europe, Asia and South America. European payments platform Market Pay, backed by private equity investor AnaCap, acquired Danish payments service provider AltaPay, omnichannel payments provider KORT Payments acquired the assets of direct marketing payments processing business Paysafe Direct, card-issuing platform Marqeta acquired TransactPay to strengthen its card management capabilities in the UK and Europe and finally on the fundraising side invoice payment platform Adfin raised €8m from existing investor Index Ventures.
- Other notable transactions this month include Monatgu Private Equity's €371m carve-out of Multifonds, a fund accounting solution that has been part of the Temenos core banking platform since 2015. Global payments processor WorldPay acquired Revelin, a London based, Al-native anti-fraud platform, and 73 Strings, an Al portfolio monitoring and valuation platform raised €55m in a Series B round which was led by Goldman Sachs and included participation from Blackstone.
