



- During April NovitasFTCL tracked 83 transactions, including 35 strategic acquisitions, 12 PE / Growth investments and 36 VC rounds. Payments recorded the largest number of deals with 30, followed by InvestmentTech with 12 and RegTech with 10. 10 transactions involved Digital Assets.
- April 2025 was a busy month in Payments with 30 deals announced in this sub-sector alone. Global Payments announced the \$24bn acquisition of WorldPay to combine complementary payments, software and commerce enablement solutions to merchants worldwide, banknote printer De La Rue agreed to a £263m deal with US private equity firm Atlas Holdings and Brookfield Asset Management agreed a long term strategic partnership and structured acquisition of up to 80% of the equity in Barclays' payment acceptance business over time. Finally, a division of Western Union acquired high street travel money business Eurochange from Corsair Capital and IFX Payments acquired AIM-listed FX platform Argentex in distress.
- In Capital Markets, Iress agreed to sell its European market data business QuantHouse to Vienna-based BAHA Tech Holding AG for €17.5m, and KKR announced the acquisition of leading post-trade solutions provider OSTTRA from CME Group and S&P Global (for an EV of \$3.1bn). smartTrade, a global provider of multi-asset electronic trading platforms, announced a strategic investment from TA Associates. Archax, the UK FCA regulated digital asset exchange, broker and custodian, acquired Globacap PMI as bridgehead to the US. Lastly TransFICC, a provider of low-latency connectivity and workflow services in the fixed income and derivatives markets, raised a \$25m Series B led by Citadel Securities.
- Other notable transactions this month include wealth management platform FNZ raising a further \$450m (at an undisclosed valuation) to bring its fundraising total to more than \$2.5bn, and UK InsurTech platform Marshmallow raising a \$90m Series C (consisting of a 50/50 split of equity and debt) at a pre-money valuation of c. \$2bn.
