
• During May NovitasFTCL tracked 76 transactions, comprising of 28 strategic acquisitions, 9 PE / Growth investments and 39 VC rounds. Payments attracted the largest number of deals with 19, followed by Banking Tech with 17 and InvestmentTech with 15. Twelve transactions involved Digital Assets.


• May 2025 was another busy month for the payments sector. Highlights include SME payments technology platform Dojo raised \$190m from Vitruvian Partners to accelerate its growth in the UK and across European markets, Dutch SME payments and banking services start-up Finom raised €92m of growth capital from existing backer General Catalyst, automotive payments platform Aufinity raised €23m led by Blackfin Capital Partners and Visa Ventures invested in stablecoin technology platform BVNK, following on from its \$50m Series B in December 2024.

• In BankingTech M&A, instant-credit provider Younited Finance acquired Helios, a French provider of sustainable banking solutions, and UK conveyancing platform OneDome acquired Trussle (t/a Betterment), a UK digital mortgage broker. On the fundraising side Tinubu Square, an InsurTech platform providing solutions for speciality insurance lines raised €40m from Morgan Stanley Expansion Capital, and Juice, a provider of non-dilutive financing solutions raised £25m from Aern Capital and Falco Group.

• Other notable transactions this month include KBC Group's acquisition of Slovakian investment platform 365.Invest for €761m, making it the largest transaction of the month with a disclosed value, and APAX Partners carved-out Finastra's treasury and capital markets division. Deal values were not disclosed.
